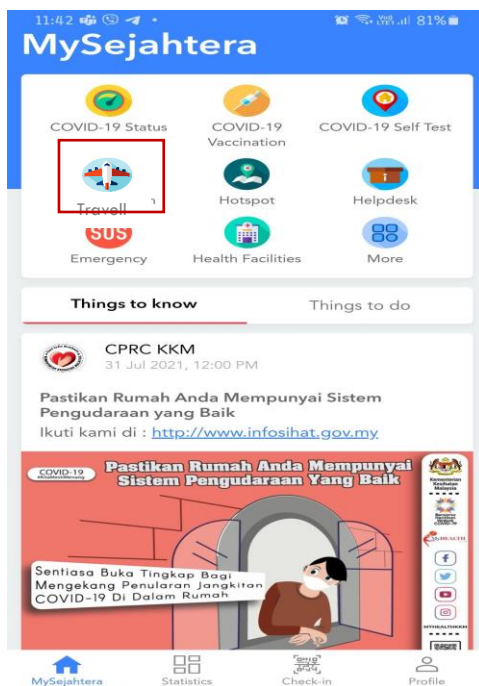
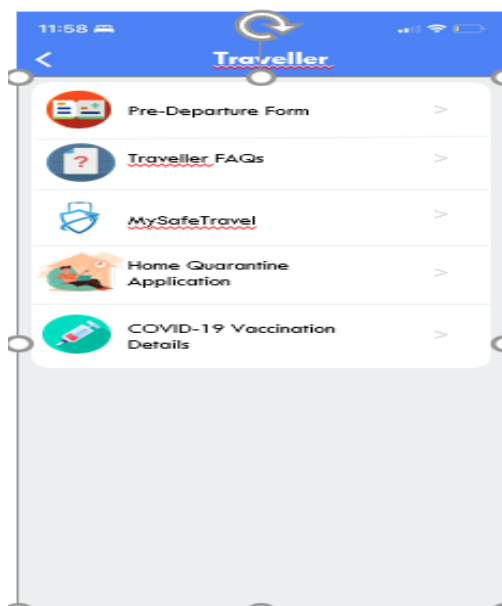


PROCEDURES FOR FILLING IN THE PRE-DEPARTURE FORM VIA THE MYSEJAHTERA APPLICATION

1. The form is to be filled before departing to Malaysia.
2. Click the **Traveller** icon on the MySejahtera homepage.



3. **Pre-departure Form** will appear on the screen. Click on the icon to view the form.



4. Fill in the personal details into the Pre-Departure Form, as shown below.

Fill in the departure and arrival dates correctly

Ensure the correct quarantine address is written.

The duration of the HSO depends on the vaccination status written on the Departure Form.

Check the information written in the Pre-departure Form before submitting it.

5. Upon submission of the Pre-departure Form, the Home Isolation or Surveillance Order (HSO) will appear on the electronic device. The duration of HSO is based on the arrival date filled in the Pre-departure Form.
